Minutes Cass County Board of Supervisors Tuesday, April 16, 2024

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green (by Zoom), Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Pettinger moved, O'Brien second, to adopt the agenda. All ayes. Motion carried.

Richter moved, Pettinger second, to approve the March 26,2024 minutes of the Public Hearing on the Proposed Property Taxes for Fiscal Year 2025. All ayes. Motion carried.

Pettinger moved, O'Brien second, to approve the April 2, 2024 regular meeting minutes. All ayes. Motion carried.

Micah Lee, Cass County Conservation Executive Director, presented the quarterly report for the months of January through March.

Jotham Arber, Executive Director of Cass/Guthrie County Environmental Health, presented the monthly report for March.

Richter moved, O'Brien second, to change the name of the Cass County Condemnation in Eminent Domain Proceedings to Cass County Eminent Domain Compensation Commission to clarify the purpose of the commission as outlined in Iowa Code 6B.4. All ayes. Motion carried.

O'Brien moved, Pettinger second, to table Resolution 2024-10, Allocating ARPA Funds to Replace a Drone for the Sheriff's Department in an amount not to exceed \$14,000 until May 21, 2024, to allow the board of supervisors to prioritize multiple funding requests. All ayes. Motion carried.

O'Brien moved, Pettinger second, to table Resolution 2024-11, Allocating ARPA Funds to Purchase a Radio System for Secondary Roads in an amount not to exceed \$100,000 until May 21, 2024 to allow the board of supervisors to prioritize multiple funding requests. All ayes. Motion carried.

Richter moved, O'Brien second, to set the Date of Public Hearing to Vacate Chicago Road west of 770th Street (the 1,000 feet west of the bridge) for April 23, 2024 at 9:15 A.M. All ayes. Motion carried.

County Engineer Trent Wolken reviewed current road projects.

Pettinger moved, O'Brien second, to table using Local Option Sales Tax (betterment) to assist the Anita Food Pantry with paving their parking lot until July 16, 2024 when the food pantry may learn if they will receive a grant that could help with the project. All ayes. Motion carried.

Pettinger moved, Green second, to appoint Alice Williams as Victoria Township Trustee effective April 17, 2024 to fill the vacancy following Donald Edwards' resignation on February 28, 2023.

Richter moved, Pettinger second, to appoint David Williamson to the Cass County Eminent Domain Compensation Commission effective April 16, 2024 as an owner-operator of agricultural property. All ayes. Motion carried.
