Minutes **Cass County Board of Supervisors** Tuesday, August 6, 2024

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green, Wendy Richter (by phone), Mark O'Brien and Bernard Pettinger. Absent: none.

Pettinger moved, Green second, to adopt the agenda as amended. All ayes. Motion carried.

Green moved, Pettinger second, to approve the July 16, 2024 minutes. All ayes. Motion carried.

O'Brien moved, Richter second, to approve the July 23, 2024 special board meeting minutes. All ayes. Motion carried.

Green moved, Pettinger second, to amend Resolution 2024-23, Approving Use of Valley Business Park Interest for use by CADCO's Revolving Loan Fund to Support Local Economic Development, to clarify the county will grant a one-time contribution of \$95,000, rather than \$60,000, to the CADCO revolving loan fund. Ayes: Baier, Pettinger, Green, O'Brien. Nays: Richter. Motion carried. Green moved, Pettinger second to approve Resolution 2024-23 as amended. Ayes: Baier, Pettinger, Green, Richter, O'Brien. Nays: None. Motion carried.

Green moved, O'Brien second, to approve Resolution 2024-24, Approving the EMS Advisory Council's Recommended Amount of Funding to be Specified on the November 5, 2024 Ballot in Accordance with Iowa Code 422D. Ayes: Baier, Pettinger, Green, Richter, O'Brien. Nays: None. Motion carried.

The board discussed the remaining ARPA fund requests, including \$227,400 for the City of Griswold's lift station for the Land of Oz Housing Development, \$25,000 for the Anita Food Pantry parking lot, \$11,430.98 for the Atlantic Police Department's school resource officer radios, and \$10,000 for the City of Griswold's splash pad. The board agreed to consider resolutions granting \$15,000 to the Anita Food Pantry's parking lot and \$35,000 for the City of Griswold's lift station at their next meeting, putting the other requests on hold, and leaving a balance of \$20,291.91 to allocate.

O'Brien moved, Pettinger second, to approve Gus Construction's low bid of \$464,492.30 for Project L83—73-15, a reinforced box culvert project on 620th Street. All ayes. Motion carried.

Trent Wolken, County Engineer, reviewed current road and equipment projects.

Debbie Schuler, Cass County Mental Health & General Relief Coordinator, presented the June and July monthly reports.
