Minutes Cass County Board of Supervisors Tuesday, October 15, 2024

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green (by Zoom), Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Richter moved, O'Brien second, to adopt the agenda as amended. All ayes. Motion carried.

Pettinger moved, Richter second, to approve the October 1, 2024 minutes. All ayes. Motion carried.

Richter moved, O'Brien second, to approve the Rural Transit System Joint Participation Agreement with Southwest Iowa Planning Council (SWIPCO) for Fiscal Year 2024-2025. All ayes. Motion carried.

Green moved, Pettinger second, to waive the deadline for the submission of the annual certification and continue operating under the terms of the Agreement for Private Development by and Between Cass County, Iowa and KLC Comes, LLC D/B/A Bluebird Hill Event Venue. All ayes. Motion carried.

The board chose to take no action to re-establish the compensation board. As a result of SF 2442, which was signed into law on May 1, 2024, the board of supervisors will assume the responsibilities of the compensation board contained in Iowa Code §331.905.

Jotham Arber, Executive Director of Cass/Guthrie County Environmental Health, presented the monthly report. He reminded the public that water testing is available for free and reimbursement, up to \$1,800, is also available for well rehabilitation.

Trent Wolken, County Engineer, reviewed current road and equipment projects.
