## Minutes Cass County Board of Supervisors Tuesday, November 19, 2024

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Richter moved, Green second, to adopt the agenda as amended (remove item number eight). All ayes. Motion carried.

Pettinger moved, O'Brien second, to approve the November 13, 2024 minutes. All ayes. Motion carried.

Corey Eberling commented on APEX Clean Energy's wind turbine project in northern Cass County.

Wendy Mueller presented the annual report on West Central Community Action.

Jotham Arber presented the monthly report on environmental health.

O'Brien moved, Pettinger second, to set the date of public hearing for December 3, 2024 to consider an application for zoning change by LANDUS Cooperative from General Agricultural District to Heavy Industrial District for property in Pymosa Township as approved by the Zoning Commission. Green moved, O'Brien second, to approve sending a letter of support for Vision Atlantic to use in grant applications. All ayes. Motion carried.

Green moved, Richter second, to approve adding a Tourism department page to the county website. All ayes. Motion carried.

Green moved, O'Brien second, to approve the first reading of Ordinance Number 39, Imposing a Local Option Income Surtax for Emergency Medical Services at a rate of one percent on the state individual income tax for 15 years in accordance with Iowa Code 422D following the November 5, 2024 General Election when Public Measure A was approved by more than 60% of those voting on the question. Ayes: Baier, Green, Hartkopf, O'Brien, Pettinger. Nays: none. Motion carried.

Mitch Holmes, Cass County Veteran Affairs Executive Director, presented the report for the quarter ending September 30, 2024.

Trent Wolken, County Engineer, reviewed current road and equipment projects.

Green moved, O'Brien second, to allow/disallow Family Farm Credits as recommended by the county assessor in accordance with Iowa Code Chapter 425A for taxes collectible in Fiscal Year 2025-2026. All ayes. Motion carried.
