The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Green moved, Pettinger second, to adopt the agenda as amended. All ayes. Motion carried.

O'Brien moved, Richter second, to approve the January 2, 2025 minutes. All ayes. Motion carried.

Diane Schultz, with Iowa Mormon Trails Association, gave an update on the replacement Mormon Trail signs. Green moved, O'Brien second, to approve a letter of agreement for Cass County Secondary Roads to receive the signs and install them. All ayes. Motion carried.
